

Consumer Information

This document serves to fulfill the statutory consumer information obligations to be fulfilled by Augmented Robotics GmbH. It was created to give you, as a purchaser of PRHX as part of the public offering of PRHX conducted by Augmented Robotics, the opportunity to view all relevant consumer information concentrated in a single document.

In addition to this document, you will receive the **general offer terms and conditions** (hereinafter: "**Offer Conditions**") on which the purchase is based.

Please read the consumer information and the Offer Conditions carefully in order to obtain comprehensive information about the terms and conditions of the acquisition of PRHX as part of the public offer of Augmented Robotics GmbH.

2. Information on the Conclusion of the Contract

Contracts between Augmented Robotics and the consumer are concluded exclusively via the Internet by means of electronic communication through offer and acceptance.

The provision by Augmented Robotics of the Offer Conditions and further documentation on the public offer of PRHX does not constitute a legally binding offer within the meaning of Sections 145 et seq. BGB to the consumer for the conclusion of a purchase contract. Rather, purchasers have the opportunity to submit a legally binding offer to Augmented Robotics via the website <https://projecthorus.ai> for the conclusion of a contract for the purchase of a number of PRHX. This requires the consumer to accept Augmented Robotics' Offer Conditions and the other documents relating to the public offer in the designated order section on <https://projecthorus.ai> and to deposit an ERC20-compatible crypto wallet to which the PRHX to be purchased are to be delivered. By successfully transferring the purchase price in USDC in accordance with the Offer Conditions to the crypto wallet address specified by Augmented Robotics in the order section at the end of the order section, the consumer makes a legally binding offer within the meaning of Sections 145 et seq. BGB for the purchase of the number of PRHX selected by the consumer from Augmented Robotics.

Augmented Robotics declares acceptance of offers from purchasers immediately after receipt of the offer in accordance with the declaration of acceptance pursuant to Clause 4.3 sentence 1 of the Offer Conditions. If the purchaser's offer is aimed at the acquisition of a quantity of PRHX that Augmented Robotics cannot transfer to the purchaser in view of the fact that a maximum of 1,791,432,897 PRHX are offered in the public offer in accordance with the Offer Conditions, Augmented Robotics will declare its rejection of the offer to the purchaser in accordance with Clause 4.3 sentence 2 of the underlying Offer Conditions.

3. Contract and Communication Language

PRHX are only offered in English and the language of communication between Augmented Robotics and the consumer is English.

4. Storage of the Contract Text

The text of the contract is made available as follows:

- During the ordering process, the consumer can download and save the contract text in the form of the underlying Offer Conditions as a PDF document.
- After completion of the order, Augmented Robotics sends a hash value and link in the form of a non-fungible token ("NFT") to the crypto wallet specified by the consumer, which the consumer can use to access the text of the contract at any time.
- Beyond this, Augmented Robotics does not store the text of the contract for the consumer.

5. Essential Characteristics of the Goods or Services

PRHX are crypto assets and so-called other crypto assets as Asset Referenced Tokens or E-Money Tokens within the meaning of MiCAR.

The PRHX were generated by Augmented Robotics on the Ethereum blockchain as ERC20 tokens. A total of 2.9 billion PRHX exist, of which 1,791,432,897 PRHX are being offered for purchase as part of the public offering.

The ownership of PRHX does not establish any rights against Augmented Robotics and does not convey any claims against other legal entities.

However, Augmented Robotics reserves the right to grant PRHX holders discounts on the purchase of services from its portfolio in the future, provided that they use PRHX to pay for the services. Augmented Robotics determines the scope and form of such discount campaigns at its own discretion.

The secure storage and management of acquired PRHX, including the private cryptographic keys, is the sole responsibility of the consumer after the transfer to the purchaser.

6. Total Price

The total price of PRHX is determined as follows:

Total Price of the PRHX

As part of the public offering, PRHX from Augmented Robotics can only be purchased in exchange for the cryptocurrency USDC. The exchange price in USDC will increase successively during the public offering over a total of ten price stages until the end of the pre-sale. The current exchange price at which PRHX can be purchased from Augmented Robotics in the public offer will be displayed to the consumer during the order process. The price levels have been set by Augmented Robotics as follows:

Additional Costs in Connection with the Purchase

In addition to the price per PRHX, there may be additional costs that must be borne by the consumer. These include:

- **Cost of Setting Up and Maintaining a Crypto Wallet:** The consumer is responsible for all expenses associated with setting up, managing and securing the crypto wallet required for the exchange.
- **Blockchain-specific Fees:** The consumer bears all fees that are required in connection with the interaction with the Ethereum blockchain or other blockchains. This includes in particular:
- **Transaction Costs (e.g. Gas Fees):** These may vary and depend on the current network utilization.

Costs for the Use of Means of Distance Communication

There are no additional costs for the use of the means of distance communication used for the conclusion of the contract that go beyond the usual usage costs.

7. Payment, Transfer and Performance Conditions

Terms of Payment

- The exchange price is the amount shown in USDC per PRHX.
- The consumer is obliged to pay in advance. The exchange price is due immediately after placement of the order.
- All costs associated with setting up and maintaining the required crypto wallet are borne by the consumer. This also includes the transaction fees required for the interaction with the Ethereum blockchain and other blockchains in connection with the exchange transaction (e.g. gas fees).

Transfer Conditions ("Delivery of the Tokens")

- The transfer and delivery of PRHX by Augmented Robotics to the purchaser shall take place after a corresponding request by the purchaser, which can be declared via the "Claim Token" button in the sale area at <https://projecthorus.ai>, but no earlier than 28 days after the completion of the 10th price stage (10th stage). PRHX that have been added to the earn program in accordance with Clause 6 of the Offer Conditions can be requested for transfer and delivery to the crypto wallet specified by the purchaser in the order process no earlier than 60 days after completion of the 10th stage.

Performance Conditions

- The transfer of PRHX shall in any case only take place after full payment has been received and after the purchaser has declared his request.

- It is expressly pointed out once again that the transfer can only be made to an Ethereum-compatible wallet. Errors when entering the wallet address can lead to the loss of PRHX.

8. Accepted Means of Payment

Augmented Robotics only accepts the following means of payment (exchange objects) for the exchange of PRHX:

- USDC

Consumers should ensure that they have sufficient USDC available in their crypto wallet to successfully complete the payment.

Other means of payment are currently not accepted.

9. Liability for Defects

Augmented Robotics' obligation to perform is limited to the transfer and transfer under property law of the PRHX ordered (see object of purchase) to the consumer's wallet. A replacement allocation or the issue of comparable PRHX is excluded. The warranty is governed by the applicable statutory provisions on warranty law.

10. Customer Service, After-sales Service and Guarantees

No further customer service, after-sales service or guarantees are offered beyond the statutory warranty claims. Of course, consumers can generally contact Augmented Robotics with complaints. All communication channels mentioned in section 1 can be used for this purpose.

11. Out-of-Court Complaint and Appeal Proceedings

Augmented Robotics is neither willing nor obliged to participate in a dispute resolution procedure before a consumer arbitration board within the meaning of § 36 VSBG.

12. No Consumer Right of Withdrawal

The consumer has no right of withdrawal.

As a rule, consumers are entitled to a right of withdrawal in accordance with Section 355 BGB for contracts concluded outside of business premises and for distance contracts. This right of withdrawal does not apply to contracts for the supply of goods or the provision of services, including financial services, the price of which depends on fluctuations in the financial market over which the trader has no control and which may occur within the withdrawal period, in particular services in connection with shares, shares in open-ended investment funds within the meaning of Section 1 (4) of the German Capital Investment Code and other tradable securities, foreign exchange, derivatives or money market instruments. Crypto assets are goods whose price depends on fluctuations in the financial market over which the trader has no influence and which may occur within the withdrawal period. Consumers therefore have no right of withdrawal when purchasing PRHX.

Notwithstanding the non-existence of a consumer right of withdrawal, Augmented Robotics expressly points out that the consumer may be entitled to a right of withdrawal in accordance with Art. 13 MiCAR in the event of the purchase of PRHX via the public offer, provided that he is classified as a retail investor within the meaning of Art. 3 para. 1 no. 37 MiCAR.

13. Possibility to Recognize Input Errors

Prior to submitting a binding offer via the Augmented Robotics website, the consumer can recognize possible input errors by carefully reading the information displayed on the screen. An effective technical means for better recognition of input errors can be the magnification function of the browser, which enlarges the display on the screen. Consumers can correct their entries during the electronic ordering process using the usual keyboard and mouse functions until they click on the button that concludes the order process.
